



# Flat/house - sharing agreement

Flat/house sharing agreements between tenants and other flatmates are not covered under the Residential Tenancies Act 1986. Tenants and other flatmates will, however, find it useful to have a written agreement.

This agreement is between the **Owner** and **Flatmate**.

<b>The flatmate and the head tenant agree to share premises on the following terms:</b>	
<ol style="list-style-type: none"><li>1. This agreement starts on the 11/05/2025 and will continue on a weekly / fortnightly basis.</li><li>2. The agreement will end on the 11/08/2025 and can be negotiated providing 14 days' notice is given and the owner accepts.</li><li>3. The rent is \$240 per week / fortnight and is to be paid weekly / fortnightly in advance by the flatmate to the owner via bank payment to 03-0318-0073680-002.</li><li>4. An advance of one week's rent (\$240) is payable to cover the final week of the agreement. This amount will be used as the final rent payment provided there is no damage or other outstanding costs, and is payable to the owner.</li><li>5. The flatmate may not sublet or transfer their right to occupy the room without the homeowner's written consent</li><li>6. This agreement can be terminated by 14 days' notice given by either party in writing.</li><li>7. The flatmate shall not keep any pets on the premises without the owner's permission.</li><li>8. The flatmate's portion of the regular utilities is included in their rent amount <b>excluding</b> food.</li><li>9. The flatmate must not remove any chattels or fixtures from the premises that do not belong to the flatmate.</li><li>10. The flatmate may use all areas of the property freely with the exception of the other bedroom and the office space, which may not be used without prior consent.</li><li>11. The flatmate agrees to follow general house rules as communicated by the owner from time to time, including reasonable expectations regarding cleanliness, guests, noise, and security</li><li>12. In the event of any dispute, the parties agree that the dispute will be determined by the Disputes Tribunal.</li></ol>
